# PUBLIC MEETING OF THE GORHAM BOARD OF SELECTMEN Gorham Town Hall Public Meeting Room 2nd Floor Monday, September 11, 2023 4:30 p.m.

SELECTMEN PRESENT: Michael Waddell; Yves Zornio; and Judy LeBlanc.

STAFF MEMBERS PRESENT: Peter Gagnon, Town Manager; and Phil Cloutier, Fire Chief.

ALSO PRESENT: Edith Tucker (Berlin Daily Sun); Ryan Byrnes (Gorham Resident)

#### 1. Non-Public Session - 4:30 p.m.

Nonpublic Session under RSA 91-A:3, II(a) The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a public meeting, and (2) requests that the meeting be open, in which case the request shall be granted; (c) Matters which, if discussed in public, would likely adversely the reputation of any person, other than a member of this board, unless such person requests an open meeting. This exemption shall extend to include any application for assistance or tax abatement or waiver of a fee, fine or other levy, if based on inability to pay or poverty of the applicant; and (d) Consideration of the acquisition, sale, or lease of real or personal property which, if discussed in public, would likely benefit a party or parties whose interests are adverse to those of the general community.

## 2. Public Session Call to Order - 5:30 p.m.

Chairperson Waddell called the public session to order at 5:32 p.m.

#### 3. New Business

a. Announce Action, if any, Taken in Nonpublic Session

#### b. New Fire/EMS Grants, Phil Cloutier, Fire Chief

Chief Phil Cloutier provided an update on the following grants:

- TC Energy Community Build Strong Foundation \$16,350
- Radio Repeater Grant

Chairperson Waddell inquired whether he could transfer his authorization to sign over to Peter Gagnon.

#### 2022 Assistant Firefighters Grant \$98,469

Chief Cloutier indicated that the radios are to be ordered. But in order to use State-bid pricing, the Selectmen have to approve it, since it's over \$10,000.

MOTION: Selectman Zornio moved to authorize the Fire Chief to purchase the equipment at approximately \$98,469, utilizing State-bid pricing. It was seconded by Vice-Chair LeBlanc.

Selectman Zornio: Aye Vice-Chair LeBlanc: Aye Chairperson Waddell: Aye

#### c. Residential Solar Petition, RSA 72:67

Peter Gagnon went over the Petition regarding the Town adopting a Solar Power Array Policy. He noted that the key that the array would be exempt from taxation. Discussion was had regarding the purview of the Board regarding this Petition. Further discussion was had regarding solar arrays, in general.

#### d. YTD Budget Update & Review

Mr. Gagnon provided the Board with the YTD budget. Vice-Chair LeBlanc requested if the Board could receive the budget once a month starting in Q4. He noted that Department Heads are starting to prep for budget time.

#### 4. Old Business/Updates

#### a. RR Street Parking Updates

Mr. Gagnon indicated he has been working with a few Consultants and stated that they will be going with plastic hangers over stickers, with a standard 90x20 lot for the parking area. He requested feedback from the Board regarding ADA requirements in the parking lot. He added that there needs to be decisions made regarding long-term storage. Discussion was had regarding whether the type of vehicle matters, as well as the length of time.

Chairperson Waddell noted that they need to come up with a revised Overnight Parking Policy. Mr. Gagnon stated that there is an updated snow removal plan. Discussion was had regarding whose obligation it was to tow cars parked improperly.

Ms. Tucker inquired when the public hearing would be scheduled, to which Mr. Gagnon responded sometime in October.

### b. Review and Accept Updates to Cemetery Rules & Regulations

Mr. Gagnon reminded the Board of what was discussed at the last meeting. He went over his discussions with the Town Garage regarding their duties with the cemetery, including the rationale.

MOTION: Vice-Chair LeBlanc moved to accept updates to Cemetery Rules and Regulations. It was seconded by Selectman Zornio.

The motion carried. (3-0-0).

Edith Tucker inquired regarding the transitioning role of Bronson Paradis and how his responsibilities differ from Mr. Gagnon's in terms of the Budget Report.

Ryan Byrnes indicated he's had calls from residents requesting cars to be towed on RR Street. Discussion was had regarding the towing process.

#### 6. Other Business

a. Review and Approve Minutes: August 28, 2023.

MOTION: Selectman Zornio moved to approved the nonpublic meeting minutes from August 28, 2023. It was seconded by Vice-Chair LeBlanc.
