



MEETING OF THE GORHAM BOARD OF SELECTMEN Gorham Town Hall Public Meeting Room 2nd Floor Monday, July 12, 2021 5:00 p.m.

1. Non-Public Session - 5:00 p.m.

Nonpublic Session under RSA 91-A:3, $\Pi(a)$ The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a public meeting, and (2) requests that the meeting be open, in which case the request shall be granted; (d) Consideration of the acquisition, sale, or lease of real or personal property which, if discussed in public, would likely benefit a party or parties whose interests are adverse to those of the general community; and (e) Consideration or negotiation of pending claims or litigation which has been threatened in writing or filed by or against the public body or any subdivision thereof, or by or against any member thereof because of his or her membership in such public body, until the claim or litigation has been fully adjudicated or otherwise settled. Any application filed for tax abatement, pursuant to law, with any body or board shall not constitute a threatened or filed litigation against any public body for the purposes of this subparagraph.

b. Craig Rennie, Director, NH Trails Bureau

Craig Rennie introduced himself to the Board. He spoke about the efforts with the Grant programs and their current status. He noted he has also spent time addressing complaints that have come into the office,

regarding landowner conflicts. He went on to discuss other things he has been doing, including meet-and-greets and Accident Reports, during his short time with the Bureau.

Mr. Rennie spoke about the Cross New Hampshire Adventure Trail group and the work they have been doing with them. Discussion was had regarding the Route 2 parking lot, as well as the proposed crosswalk to Casey's Way.

Ms. Vallee spoke about the Recreational Impact Survey being done and the results will reflect the summer and winter seasons in Gorham.

c. OHRV Ordinance - Updated

Discussion was had regarding the amendments made. Chairperson Waddell read the updated Ordinance.

Ms. Vallee noted she got the design for the crosswalks from Mike O'Donnell, which is just slightly different than the piano design from before. She described the design, which the Public Works Department will also use for the crosswalks that are parallel to Main Street.

b. Libby Pool - Update

Ms. Vallee stated that Libby's is full and that the Emergency Application was approved. She described the work that was done on Libby Pool.

c. Zoning Board Application & Short-Term Rental Flow Chart
