 Grant, through the USDA, that she is exploring.
- Ms. Vallee indicated that the Lancaster Road Project is still being voted on by the Congress.
- Ms. Vallee indicated that Phil was awarded a Grant from Eversource to purchase a new compressor for the Fire Department.
- Ms. Vallee announced that Carol, the Town Clerk/Tax Collector, will be retiring officially on October 1, 2021. Her last day with the Town will be September 30, 2021. She added that Grace will be working four days a week to keep the office running, and that once new Staff are trained, Grace will be retiring for good, as well. The Board thanked both of them for their many years of service and efforts in the transition.
