At 5:00 pm, the meeting was opened by Chairman Waddell.

VOTE TO GO INTO NON-PUBLIC SESSION:

At 5:00 pm. Selectman Judy LeBlanc made a motion to go into non-public session under RSA 91-A:3,II, (a, d & e). The motion was seconded by Selectperson Adam White.

A roll call vote was taken. Selectman White voted yes, and Selectperson LeBlanc voted yes. Chairman Waddell voted yes. Motion Passed.

RSA 91-A:3,II (e) Consideration or negotiation of pending claims or litigation which has been threatened in writing or filed by or against this board or any subdivision thereof, or by or against any member thereof because of his or her membership therein, until the claim or litigation has been fully adjudicated or otherwise settled.

The Board discussed several Abatement Cases, Tax Deeding and the OHRV Case.

RSA 91-a:3,II, (a) The dismissal, promotion, or compensation of any public employee or the disciplining of such employee, or the investigation of any charges against him or her, unless the employee affected (1) has a right to a public meeting, and (2) requests that the meeting be open, in which case the request shall be granted.

The Board discussed personnel matters involving the Town Clerk/Tax Collector Department.

At 5:59 pm, Selectperson LeBlanc made a motion to recess the non-public meeting until after the regular meeting. The motion was seconded by Selectman White. A roll call vote was taken. Chairman Mike Waddell voted yes, Selectman Adam White voted yes and Selectperson Judy LeBlanc voted yes. Motion Passed.




The Board discussed personnel matters involving the Police & Dispatch Department and Public Works Department and Health Insurance.
