d. Land Acquisition Project

Chairperson Waddell provided a background regarding the Land Acquisition Project for four Bayroot LLC properties to be added to the Town Forest.

MOTION: Vice-Chair LeBlanc moved to approve and support the acquisition of 1,109 acres with the Conservation Fund. It was seconded by Selectman Zornio.

Ms. Vallee indicated she got an email from Neal Bungard of the Community Forest this afternoon, where he said they received more than 25 applications across the country, and in only two other years since 2012 were there more applications submitted than that. Total ask for project acquisition funds is \$10.8 million and Community Forest was funded for \$6 million this year.

e. Building Permit Applications

Chairperson Waddell went over the process that they are undertaking to review and/or approve the Building Permit Applications. He added that Chief Phil Cloutier is willing to take the simpler Applications or ones that only pertain to the Fire Department and sign off on them.

Stony Brook Update

Ms. Vallee indicated she has the next-to-last bill for the preliminary RFP work and that she signed off on the Wetlands Permit for the project.

Solar Project

Ms. Vallee indicated, as part of the USDA Grant Application, the Town had to get two other proposals, and that the company doing the Ed Fenn (elementary school, SAU#20) Solar Project came in with a cost for the project of \$152,000 instead of \$219,000. She went on to state that they do not need to apply for the USDA Grant and that instead they will do the CDFA loan for the non-Federal match, coupled with the \$30,000 out of the capital reserve fund. She added it should cost the Town \$16,000 for the whole project. Discussion was had regarding the scheduling of the project.
