Fire and EMS

Fire and EMS members continue responding to calls, with motor vehicle accidents being the majority of call volume. Due to drought conditions across the state, FD Officers were kept busy responding to open burn complaints. Residents were advised of the brush fire burn and were allowed to continue any legal size, permitted fires. Residents are advised to always have access to water and standby any burning fires at all times.

Engine 3 and Engine 4 were run through their annual pump tests. Both trucks were able to meet the required gallons per minute and length of test points. Annual pump testing allows us to monitor the status of our pumps and ensure they are ready to respond when needed.

EMS members viewed many different Ambulance demos as we continue to refine what we are looking for in our next ambulance. The Duty Crew has also been busy bringing two new hires up to speed as we continually look to boost our call member roster. Members have been attending recertification training as we move towards another March deadline for our bi-annual recertification. Following are EMS call stats for September:
