I would like to respectfully submit my comment for the next meeting:

I would like to address the concerns of our neighborhood located at 7 Dublin Street with regards to The ATV/ snowmobile rental company Northeast.

Would like to respectfully request a noise study and traffic impact for all of the residents that reside on 7 Dublin Street.

Since Northeast has moved to the old Bank of New Hampshire location The volume of noise and traffic it has created centralized in the middle of town is becoming more than just a nuisance, It has been destructive to our sidewalks, visual aesthetics, an overall major increase in noise for the entirety of main Street.

I would like to request that this noise and traffic impact study be implemented as well as make a suggestion that if they are going to continue rentals within our community they need to put noise reducing mufflers which range anywhere is from \$40-\$60. I believe that this is a reasonable request considering that they charge upwards of \$300 per unit per day to rent absorbing the cost of the noise reducing mufflers will alleviate the need of impacting any wildlife in our area by installing a large fence which is proven to be not helpful.

When Burger King was open you could hear audibly idling 18-wheelers which the decibel level is far less than ATVs. Now take that and multiply that by 200 units and then twice per day per unit coming in and out of Gorham at the very least via pickup and drop off of the rental not including any stops they may take or return into Gorman for food or gasoline.

The ATV rental company has made GORHAM less desirable to live in as a full-time resident, It is far more dangerous to even walk on the sidewalks because they are damaged so much that they are slanting at a 45° angle pitted very aggressively from studd marks cracked with green vegetation growing out of them. Not to mention while walking my son to school on said sidewalks, trying to navigate past the ATV rental company first thing in the morning when ATVs are leaving proves to be dangerous for the children walking to school.

little to no attempt at repairing the sidewalks has been made by the town of Gorham and several years. Perhaps requiring rental companies that rely on travel up and down sidewalks, perhaps if Gorham instituted paying a "trail fee" to the town of Gorham for utilization of the sidewalks, much like you have to in order to travel on any of the trails by joining a trail club. They take these trail club fees to repair the trails when they are damaged so why wouldn't Gorham be able to institute a trail fee to repair the sidewalks that are damaged by ATVs and snow machines.

Please heed the town taxpayers requests and consider them deeply, instead of being dismissive.
