

**ADVERTISEMENT FOR BIDS  
STONY BROOK ROAD RECONSTRUCTION, GORHAM, NH**

Sealed Bids for the construction of the **Stony Brook Road Reconstruction**, located in Gorham, NH will be received by the Town of Gorham, at the office of HEB Engineers, Inc. (mailing address: PO Box 440, North Conway, NH 03860), until **2:00 p.m.** local time on **May 31, 2019**, at which time the Bids received will be publicly opened and read. The Project generally consists of:

**Reconstruction of Stony Brook Road and a portion of Mount Carter Drive.**

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with additive alternate bid items as indicated in the Bid Form.

The Issuing Office for the Bidding Documents is: HEB Engineers, Inc., PO Box 440, 2605 White Mountain Highway, North Conway, NH 03860, (603) 356-6936. Prospective Bidders may examine the Bidding Documents at the Town of Gorham, the Issuing Office on Mondays through Fridays between the hours 9:00 a.m. and 4:00 p.m. (please call for availability), and on [www.constructionsummary.com](http://www.constructionsummary.com).

Bidding Documents may be obtained from the Issuing Office in electronic format (.pdf only) at no cost. Paper copies are available either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$90 per set, payable to HEB Engineers, Inc. An additional charge of \$15 for regular postage or \$30 for overnight postage will be applied to requests for mailed documents. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

To be considered a responsive Bidder, the Contractor shall have obtained at least one set of electronic or paper plans and specifications from the Engineer (HEB Engineers, Inc.). The Bid will not be awarded to a Bidder unless a record for the purchase of at least one set of electronic or paper plans and specifications exists in the office of the Engineer. To meet this requirement and to be added to the official list of plan holders, a prospective Bidder must request electronic copies or purchase paper plans and specifications using the name that is to appear in the Bid Documents.

A pre-bid conference will be held at the Gorham Town Hall, local time on **Wednesday, May 22, 2019 at 9:00 a.m.** **Attendance at the pre-bid conference is strongly encouraged.**

Bid security in the amount of **\$5,000** must be provided with each Bid in accordance with the Instructions to Bidders. The Successful Bidder shall furnish 100 percent Performance and Payment Bonds in accordance with the Instructions to Bidders (Section 00200). **Notice to Proceed is expected to be July 29, 2019 and construction is expected to start August 5, 2019. Project is subject to permitting. The Work is to be substantially complete by October 4, 2019 and completed and ready for final payment on or before October 25, 2019.** Liquidated damages of \$500 per day will commence on **October 5, 2019** for failure to complete the Work within the stipulated contract times.

Along with the Bid, the Bidder shall supply Certificates of Insurance to the Owner, as defined in the Supplementary Conditions. **The Owner and Engineer shall be named as additionally insured.**

The Bidder shall submit to the Owner and Engineer a list identifying all Subcontractors, Suppliers, and other persons and organizations that are to furnish principle items of material and equipment. The list shall be submitted with the Bid. The contractor shall also complete the Bidder Qualification Statement with supporting data (00410-B) and submit with the bid.

The apparent Successful Bidder shall submit a Qualifications Statement for each Subcontractor, Supplier and other person and organization requested, if any. The Qualification Statement(s) shall be submitted within five days of the Owner's or Engineer's request. Any such Subcontractor, Supplier, or other person or organization so identified may be revoked on the basis of reasonable objection after due investigation, in which case Contractor shall submit an acceptable substitute, without an increase in Bid price.

The Owner reserves the right to reject any and all Bids, to waive any and all informalities not involving price, time or changes in the Work, and to negotiate contract terms with the Successful Bidder, and the right to disregard all non-conforming, non-responsive, unbalanced or conditional Bids. Also, Owner reserves the right to reject the Bid of any Bidder if Owner believes that it would not be in the best interest of the Project to make an award to that Bidder, whether because the Bid is non-responsive, or the Bidder is unqualified or of doubtful financial ability, or fails to meet any other pertinent standard or criteria established by Owner. Discrepancies in the multiplication of units of Work and unit prices will be resolved in favor of the unit prices. Discrepancies between the indicated sum of any column of figures and the correct sum thereof will be resolved in favor of the correct sum.
